Room.

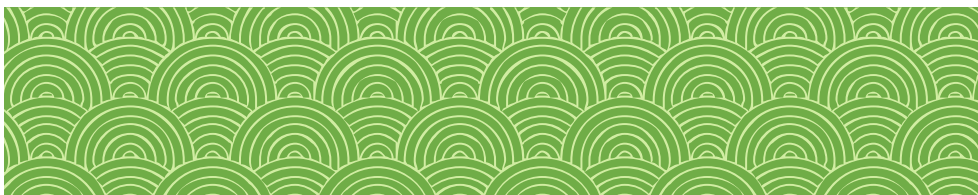
